Part B. Free Summary of CV (Max. of 3.500 characters, including spaces)

Ms. Beatriz Cuadrado Ballesteros holds a degree in Business Administration and Management from the University of Salamanca (2009), where she also obtained her PhD in Business Economics (2012), after completing the Master's Degree in Applied Economic Analysis at the University of Alcalá de Henares. Her doctoral thesis obtained the highest qualification (Outstanding Cum Laude) and the Extraordinary Doctorate Award from the University of Salamanca. She began teaching in 2010, obtaining a position as a Full Professor at the University in 2019. Throughout these years, she has taught undergraduate and master's subjects with great success, obtaining the highest qualification in the Docentia Program (University of Salamanca) in 2014/2015 and 2020/2021. She has directed more than 40 undergraduate theses and 8 master's theses, led 7 teaching innovation and improvement projects, and participated in another 4 as a team member.

Her research activity has been extensive and multidisciplinary, although with a common thread: sustainability and social responsibility, in both the public and private sectors. On the one hand, she has studied the economic and financial sustainability of public administrations, analyzing the various forms of service delivery, as well as government accountability and good governance. Her current research focuses on gender equality and the implementation of the Sustainable Development Goals in public organizations. She has also participated in research on corporate social responsibility in the private sector, emphasizing her contributions to issues of gender equality and family businesses. She has developed this second area of research as a team member on three research projects, which were competitively run at the national or regional level. Her studies have been published in high-impact international journals, giving rise to more than 80 publications, of which 59 are in journals indexed in the Journal Citation Reports (JCR), 18 of them being in the first quartile and 21 in the second quartile. In Google Scholar, she has 4.515 citations (May 2025), which represents an h-index of 35 and an i10 index of 62. As an additional relevant merit, I would highlight the nomination for the "2021 Best Paper Award" in Business Ethics, Environment and Responsibility, an international journal with a JCR index of 6.967 (2020) and ranked in the first decile (2nd out of 56) in the "Ethics" category. Based on all her publications, she obtained a positive evaluation for the 2012-2017 and 2018-2023 periods in the evaluation of research activity by the CNEAI. He has also participated in more than 40 national and international congresses and conferences, presenting and disseminating the most relevant results of his research. At some of these events, he has received several awards for best communication, especially in the areas of social responsibility. This has allowed him to create work networks with researchers from other universities, where he has carried out various research stays, such as the University of Salerno, the University of Coimbra, Lancaster University and the University of Edinburgh.

Finally, regarding her management activities, it is worth highlighting her coordination of various specific training courses, coordination of outgoing Erasmus students, participation in various committees of the Faculty of Economics and Business, and her participation as a member of the editorial committee of the JPBAFM.
