Dr. Jennifer Martínez-Ferrero holds a Bachelor's degree in Business Administration and Management from the University of Salamanca (2011), where she obtained her Doctorate in Business Economics (2013) with international mention. She received the highest grade (Outstanding Cum Laude) and the Extraordinary Doctorate Award from the University of Salamanca. Since July 2019, she has been a Full Professor at the Faculty of Economics and Business, where she began her teaching activities in 2011. Since then, she has taught in all undergraduate programs at the Faculty and has actively participated in postgraduate teaching. She received an excellent rating in the Docentia Program for the 2015/16 and 2021/22 academic year. She has co-directed three doctoral theses, all graded Cum Laude, supervised 35 Master's theses, more than 35 Bachelor's theses, and has been responsible for competitive projects in Teaching Innovation.

Her research, focused on sustainability, corporate governance, and gender diversity, is summarized in notable figures: (i) 100 research articles in high-impact international journals, approximately 75% of which are in the first or second quartile; (ii) 10 book chapters; (iii) editor of special issues in high-impact journals and research books on socially responsible management topics. She has actively participated in national research projects, leading as the principal investigator a competitive project from the Ministry of Science and Innovation until 2025, linked to a specific program at the University of Salamanca. She has signed various articles and research contracts with entities such as the Economic and Social Council (Junta de Castilla y León), Bureau Veritas, the Santander Bank Chair, the Municipal Society of Tourism, Commerce, and Economic Promotion of Salamanca, and large companies like Galerías Gildo SA. She is a member of the Consolidated Research Unit of the Junta de Castilla y León and has led the Research Group in Accounting of the Maruri Hergar Foundation, in collaboration with the CEF Publisher. Moreover, she is the responsible for tthe Excellence Unit "Economic Management for Sustainability" of the Junta de Castilla y León.

participated national in more than 100 and international congresses/conferences, and her research on sustainability and gender diversity has been awarded on several occasions, such as at the Corporate Responsibility Research Conference 2017 and at the 14TH EURAM Annual Conference. All this is complemented by various postdoctoral research stays, such as at the University of Lancaster (UK), Coimbra (Portugal), Gronninigen (Netherlands) and University of Rosario (Bogotá, Colombia) and more than 12 short stays linked to the Erasmus + Program for teaching mobility of professors. As a result of her international recognition, she has been included in the "Ranking of the World Scientists: World's Top 2% Scientists" since 2021. This recognition is added to several awards received, such as the VII "Carlos Cubillo Valverde" Award for the best article published in the Journal of Accounting.

Regarding management activities, she participates in the evaluation committee of several international journals; she has been Academic Director of Postgraduate Studies at the University of Salamanca and is currently the vice-secretary of the Spanish Association of University Accounting Professors (ASEPUC).
